Internship Job Responsibilities & Duties:

I will be interning in the department of Public Relations at the Peres Center for Peace. Using skills I have gained from the School of Media and Public Affairs at GW, I will be communicating with international news outlets regarding the center's upcoming and recent events. My responsibilities include drafting press releases and assisting the PR department with additional projects-- such as the blog and other social media outlets. By interning at the Peres Center for Peace in Tel Aviv, I will gain the skills I need to become an ideal applicant to work at the United States Institute of Peace when I graduate next spring.

The past three years have been a blessing. I worked tirelessly to create a powerful network of ambitious and inspiring mentors who have taught me more than a textbook ever could. My professors have shown me how to focus my efforts to pursue my dreams, and for that I will forever be thankful. These experiences have lead me to the Massachusetts State House, the US Senate, and now— Israel.

This internship is imperative to fulfilling my career and academic aspirations. The time has come to take what I have learned in our classrooms to the complex professional world of Middle East diplomacy.
